TERMS AND CONDITIONS

The following terms and conditions are an integral part of this application for appearance bond No. _____ dated _____ for INTERNATIONAL FIDELITY INSURANCE COMPANY or its agent shall receive a premium in the amount of _____ (\$ _____) Dollars. And the parties agree that said appearance bond is conditioned upon full compliance of all said terms and conditions and is a part of said bond and application therefore.

1. THE INTERNATIONAL FIDELITY INSURANCE COMPANY, as bail, shall have control and jurisdiction over the principal during the term for which the bond is executed and shall have the right to apprehend, and arrest and surrender the principal to the proper officials at any time as provided by law.
2. In the event surrender of principal is made prior to the time set for principal's appearances, and for reason other than as enumerated below in paragraph 3, then principal shall be entitled to a refund of the bond premium.
3. It is understood and agreed that the happening of any one of the following events shall constitute a breach of principal's obligations to INTERNATIONAL FIDELITY INSURANCE COMPANY hereunder, and INTERNATIONAL FIDELITY INSURANCE COMPANY shall have the right to forthwith apprehend, arrest, and surrender principal, and principal shall have no right to any refund of premium whatsoever. Said events which shall constitute a breach of principal's obligations hereunder are:
 - (a) If principal shall depart the jurisdiction of the court without the written consent of the court and INTERNATIONAL FIDELITY INSURANCE COMPANY of its Agent.
 - (b) If principal shall move from one address to another without notifying INTERNATIONAL FIDELITY INSURANCE COMPANY, or its Agents in writing prior to said move.
 - (c) If principal shall commit any act which shall constitute reasonable evidence of principal's intention to cause a forfeiture of said bond.
 - (d) If principal is arrested and incarcerated for any offense other than a minor traffic violation.
 - (e) If principal shall make any material false statement in the application.

- 1. That the undersigned will have the aforesaid _____ forthcoming before the above court named in said bond, attached hereto, at the time therein fixed, and from day to day and term to term thereafter, as may be ordered by the said court.
- 2. That the undersigned will at all times indemnify and save the said SURETY harmless from and against every and all claim, demand, liability, cost, charge, counsel fee, expense, suit order, judgment or adjudication whatsoever which the said SURETY shall or may for any cause at any time sustain or incur, by reason or in consequence of the said SURETY in funds in meet every claim, demand, liability, cost, charge, counsel fee, expense, suit, order, judgment or adjudication against it, by reason of such Suretyship, and before it shall be required to pay the same.
- 3.
